ORDER:

In the G.O. first read above, based on the recommendations of the One Man Committee (2008), orders were issued enhancing the stitching charges from Rs.145/- to Rs.180/- per pair of the uniform supplied to the eligible male employees and Rs.22/- to Rs.45/- for stitching of each blouse piece supplied to the eligible female employees in the State.

2. In the G.O. second read above, based on the recommendations of Tenth Pay Revision Commission, orders were issued on implementation of Revised Pay Scales, 2015 to the Government employees of the State.

3. The Tenth Pay Revision Commission, inter alia, recommended enhancement in the stitching charges from Rs.180/- to Rs.300/- per pair in respect of male employees and from Rs.45/- to Rs.100/- per blouse in respect of women employees.

4. Government accepted the above recommendation and hereby order enhancement of the stitching charges to the categories of Last Grade Services/ General Sub-ordinate Services and Work charged employees who are required to compulsorily wear uniform as per rules, from the existing rates of Rs.180/- to Rs.300/- per pair in respect of male employees and from Rs.45/- to Rs.100/- per blouse in respect of women employees.

5. These orders shall come into effect from the date of issue of this G.O.
