Konda Laxman Telangana State Horticultural University (SKLTSHU), Mulugu, Siddipet Dist. **under PAYMENT QUOTA** for the Academic Year 2020-21 *viz.*, B.Sc.(Hons.) Agriculture & B.Sc.(Hons.) Horticulture based on the Ranks obtained in the Telangana EAMCET–2020 will be held at the **University Auditorium**, **PJTSAU**, **Rajendranagar**, **Hyderabad** as per the schedule mentioned below:

<u>Eligibility:</u>

- A pass in two-year Intermediate Examination conducted by the Board of Intermediate Education, Telangana State or any other examination recognized as equivalent there to by the University or Intermediate Board with the following subjects namely:
 - i) Physical Sciences
 - ii) Biological Sciences

Criteria for selection:

- The selection of the candidates in B.Sc. (Hons.) Agriculture and B.Sc.(Hons.) Horticulture under payment quota shall be based on the ranks obtained in Telangana State EAMCET-2020 duly following the rule of reservation. The rule of reservation under farmers quota (@ 40%) will also apply for payment quota seats.
- In case of a tie in ranks obtained by two or more candidates in the Telangana State EAMCET-2020, the marks secured in the optional subjects of the qualifying examination (Intermediate) shall be taken into consideration. In case of a further tie, the age of the candidate shall be taken in to consideration and the older candidate shall be given preference.

Age:

• The candidates for admission into B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture courses should have completed 17 years of age and the upper age limit shall be 22 years for all the candidates, 25 years in respect of SC and ST candidates and 27 years for Physically Challenged candidates as on 31st December of the year of admission.

Reservation of Seats:

• The rule of reservation (OC:50%, BC-A:7%, BC-B;10%, BC-C:1%, BC-D:7%, BC-E:4%, SC:15% & ST:6%) will be followed as per the rules.

Allocation of seats:

• 85% of the seats are reserved for local candidates and 15% of seats are un-reserved.

Hostel facility:

- Hostel facility will be provided subject to availability of accommodation at the respective colleges.
- The fee particulars in respect of B.Sc.(Hons.) Agriculture and B.Sc.(Hons.) Horticulture under Payment Quota are as follows:

• The hostel and mess charges are additional/extra.

Original certificates to be produced at the time of counselling:

- SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
- Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).
- Telangana State EAMCET-2020 Hall Ticket and Rank Card.
- Bonafide / Study Certificate from 6^{th} to 12^{th} Class.
- Transfer Certificate.
- Residential Certificate.
- The latest certified copy of the Social Status Certificate issued by the competent authority in case of applicants belonging to Backward Classes, Scheduled Castes and Scheduled Tribes.
- Non-Municipal Area Study Certificate (Form-I).
- Agricultural Land Holding Certificate (Form-II).

The candidates seeking admission under payment quota seats may note the following:

- The candidates attending the counselling under payment quota should bring only **Demand Draft/s** (No other means of payment are allowed) for Rs. 10,12,890 (Ten Lakhs Twelve Thousand Eight Hundred Ninety Rupees only) drawn in favour of THE COMPTROLLER, PJTSAU PAYABLE AT S.B.I., RAJENDRANAGAR, Hyderabad from the Bank Account of the candidate or parent only and Rs. 37,110/- (Thirty Seven Thousand One Hundred and Ten only) in cash for immediate payment at counseling centre at the respective allotted college counter in the event of selection of the candidate for admission.
- The candidates who secure seat should submit requisite Demand Draft/s immediately and pay the amount of Rs.37,110/- Thirty Seven Thousand One Hundred and Ten only). No further/additional time will be given for submission of Demand Draft and payment of fees.
- In the event of cancellation of the payment seat, the fees shall be refunded through a cheque issued either on the name of student or parent, duly deducting the cancellation fees of Rs. 4,000/- for General and Rs. 2,000/- for SC/ST/PH candidates.
- The candidates selected under payment quota will be treated on par with regular students. No special amenities or facilities will be provided.
- The candidates admitted under this quota are not eligible for any reimbursement of fee or any other educational concessions offered by the Government.
- If the admitted candidate cancels his/her seat **before the closure of admissions** for the Academic Year 2020-21 an amount of Rs. 4,000/- for General and Rs. 2,000/- for SC/ST/PH candidates shall be collected as cancellation fee. The fees already paid during admission shall be refunded.
- No refund of fee shall be made after closure of admissions process for the AY 2020-21.
- If the candidates opt sliding and shifting from payment quota to general quota, the differential amount shall be refunded to the account of candidate / parents.
- If the candidate has already joined in any course in either of the three Universities (PJTSAU, PVNRTVU and SKLTSHU) by paying the requisite fee under regular quota, and if he/she opts for seat under payment quota, the fee already paid under regular quota will be adjusted therein.
- More number of candidates have been called for counseling, hence, admission is not guaranteed and the seats will be allotted based on ranks obtained in Telangana State EAMCET-2020 and rule of reservation.
- The counseling process is likely to extend late in the evening; hence the candidates and parents/ guardians are requested to come well prepared for the same.
- Candidates shall have to attend the counseling at their own cost.
- The University does not guarantee any employment to the candidates.
- The applicant is informed that mere submission of online application and attending for counselling does not guarantee a seat.
- Candidates are required to read the PROSPECTUS thoroughly before attending the counselling.
- In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned.
- The parents and candidates should regularly visit the University website <u>www.pjtsau.edu.in</u> for any further information.
- Professor Jayashankar Telangana State Agricultural University (PJTSAU) is the only Agricultural University in the State. The University has not accorded any affiliation to any private colleges in Telangana State.
