SPOT counselling for the candidates who have submitted their **ONLINE application** for admission into Bi.P.C. Stream Courses of Professor Jayashankar Telangana State Agricultural University (PJTSAU), Hyderabad and Sri. Konda Laxman Telangana State Horticultural University (SKLTSHU), Mulugu, Siddipet Dist. **under PAYMENT QUOTA** for the Academic Year 2020-21 *viz.*, B.Sc.(Hons.) Agriculture & B.Sc.(Hons.) Horticulture based on the Ranks obtained in the Telangana EAMCET–2020 will be held at the **University Auditorium**, **PJTSAU**,

Rajendranagar, Hyderabad as per the schedule mentioned below:

- Large number of candidates have been called for counseling, hence, admission is not guaranteed.
- Candidates are informed to visit website www.pjtsau.edu.in for latest information and also for seat availability position before attending the counselling.
- Vacancies if any arise even on the date of counselling will also be considered for counselling process.
- As this is a Mop Up (Spot counselling), if candidates of one social category are not available for admission, such seats will be shifted to another social category as per the rule of reservation (G.O.Ms.No.74, Dated: 28-07-2011). Hence, all the applicants of all categories (OC, BC-A, B, C, D, E, SC & ST-BOTH NON-FARMERS & FARMERS) may attend the counselling.
- Very few seats are available in UR category as indicated in the seat index. Hence, Non-Local candidates are informed to visit the website for seat availability position before attending the counselling.
- In the event of cancellation of the payment seat, the fees shall be refunded through a cheque issued either on the name of student or parent, duly deducting the cancellation fees of Rs. 4,000/- for General and Rs. 2,000/- for SC/ST/PH candidates.
- If the admitted candidate cancels his/her seat **before the closure of admissions** for the Academic Year 2020-21 an amount of Rs. 4,000/- for General and Rs. 2,000/- for SC/ST/PH candidates shall be collected as cancellation fee. The fees already paid during admission shall be refunded.
- No refund of fee shall be made after closure of admissions process for the AY 2020-21.
- However, if the candidate has already joined in any course in either of the two Universities (PJTSAU and SKLTSHU) by paying the requisite fee under payment quota, and if he/she opts for seat under regular quota, the fee already paid under payment quota shall be refunded.
- If the candidate has already joined in any course in either of the three Universities (PJTSAU, PVNRTVU and SKLTSHU) by paying the requisite fee under regular quota, and if he/she opts for seat under payment quota, the fee already paid under regular quota will be adjusted therein.
- The seats will be allotted based on ranks obtained in Telangana State EAMCET-2020 and rule of reservation.
- For the Un-Reserved quota, any candidate from Telangana / Andhra Pradesh with TS EAMCET-2020 Rank can compete on the basis of merit and rule of reservation.
- This notification shall be treated as an individual intimation and no separate intimation will be issued
- All Categories means the candidate belonging to OC, BC, SC and ST including Non-Farmer and Farmer.
- The candidates need to attend the counselling on the scheduled day and time as per the ranks indicated above.
- The candidates admitted under this quota are not eligible for any reimbursement of fee or any other educational concessions offered by the Government.

Eligibility:

- A pass in two-year Intermediate Examination conducted by the Board of Intermediate Education, Telangana State or any other examination recognized as equivalent there to by the University or Intermediate Board with the following subjects namely:
 - i) Physical Sciences
 - ii) Biological Sciences

- The selection of the candidates in B.Sc. (Hons.) Agriculture and B.Sc. (Hons.) Horticulture under payment quota shall be based on the ranks obtained in Telangana State EAMCET-2020 duly following the rule of reservation. The rule of reservation under farmers quota (@ 40%) will also apply for payment quota seats.
- In case of a tie in ranks obtained by two or more candidates in the Telangana State EAMCET-2020, the marks secured in the optional subjects of the qualifying examination (Intermediate) shall be taken into consideration. In case of a further tie, the age of the candidate shall be taken in to consideration and the older candidate shall be given preference.

Age:

The candidates for admission into B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture courses should have completed 17 years of age and the upper age limit shall be 22 years for all the candidates, 25 years in respect of SC and ST candidates and 27 years for Physically Challenged candidates as on 31st December of the year of admission.

Reservation of seats for the candidates coming from families of Agriculturist cum Rural Area (Farmers' Quota):

- Forty per cent (40%) of the seats in the PJTSAU & SKLTSHU are reserved for candidates coming from families of Agriculturists (Farmers) owning not less than ONE acre of land either in the name of the parents or in the name of the candidates and who have studied for a minimum of 4 years in schools located in Non-Municipal areas.
- > If the land is owned by grandfather, grandmother or guardian or any other relations reservation is not acceptable under farmer quota.
- **FORM-I:** It is a proforma to be certified by **the Head Master** of the School with his office seal that the candidate has studied for a minimum period of four years in schools located in Non-Municipal areas during their period of study from 1st class to 12th class / Intermediate (Non-Municipal Area Certificate).
- **FORM-II:** It is a proforma indicating the patta numbers and extent of land owned by the **candidate** / parents duly certified by the Tahsildar with his office seal (or) the candidate has to upload attested photocopies of pattadar pass book as an evidence of the extent of agricultural land.
- Form-I and Form-II need to be filled in with the signatures of concerned officials viz., concerned Head of Institution and Tahsildar, respectively, along with office seal. Otherwise, the claim of the candidates under this category will be summarily rejected.

Reservation of Seats:

The rule of reservation (OC:50%, BC-A:7%, BC-B;10%, BC-C:1%, BC-D:7%, BC-E:4%, SC:15% & ST:6%) will be followed as per the rules.

Allocation of seats:

85% of the seats are reserved for local candidates and 15% of seats are un-reserved.

Hostel facility:

Hostel facility will be provided subject to availability of accommodation at the respective

The candidates seeking admission under payment quota seats may note the following:

- The candidates attending the counselling under payment quota should bring only **Demand Draft/s** (**No other means of payment are allowed**) for Rs. 10,12,890 (Ten Lakhs Twelve Thousand Eight Hundred Ninety Rupees only) **drawn in favour of THE COMPTROLLER, PJTSAU PAYABLE AT S.B.I., RAJENDRANAGAR, Hyderabad** from the Bank Account of the candidate or parent only and Rs. 37,110/- (Thirty Seven Thousand One Hundred and Ten only) in cash for immediate payment at counseling centre at the respective allotted college counter in the event of selection of the candidate for admission.
- The candidates are not allowed for counselling without Demand Draft of the above requisite amount.
- The candidates who secure seat should submit requisite Demand Draft/s immediately and pay the amount of Rs.37,110/- (Thirty Seven Thousand One Hundred and Ten only). No further/additional time will be given for submission of Demand Draft and payment of fees.
- The candidates selected under payment quota will be treated on par with regular students. No special amenities or facilities will be provided.
- The counseling process is likely to extend late in the evening; hence the candidates and parents/guardians are requested to come well prepared for the same.
- Candidates shall have to attend the counseling at their own cost.
- The University does not guarantee any employment to the candidates.
- The applicant is informed that mere submission of online application and attending for counselling does not guarantee a seat.
- Candidates are required to read the PROSPECTUS thoroughly before attending the counselling.
- In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned.
- The parents and candidates should regularly visit the University website <u>www.pjtsau.edu.in</u> for any further information.
