All the candidates who have applied for admission into B.Tech.(Agricultural Engineering) and B.Tech.(Food Technology) under farmers' quota are informed to attend the counselling on 20-11-2020.

Eligibility:

- A pass in two year Intermediate Examination conducted by the Board of Intermediate Education or any other examination recognized as equivalent thereto by the University or Intermediate Board with the following subjects namely:
 1. Physical Sciences
 2. Mathematics
- A candidate should have studied in a Non-Municipal Area for at least four years between 1st class to Intermediate or its equivalent.
- Minimum **ONE** acre of land either in the name of the parents or in the name of the candidates. If the land is owned by grandfather, grandmother or guardian or any other relations is not acceptable.
- The selection of candidates for all the seats shall be made on the basis of ranks obtained by the candidates in **Telangana State EAMCET-2020** in their respective local areas out of the merit list prepared for this purpose. The candidates will be selected based on merit by following rule of reservation.
- The candidates for admission to these courses shall be required to have completed 17 years of age with an upper age limit of 22 years for all the candidates, 25 years in respect of SC and ST candidates and 27 years for Physically Handicapped candidates as on 31st December of the year of admission.
- **FORM-I:** It is a proforma to be certified by **the Head Master** of the school with his office seal that the candidate has studied for a **minimum period of four years in schools/colleges located in Non-Municipal areas** during their period of study from 1st class to 12th class / Intermediate (**Non-Municipal Area Study Certificate**) (to be uploaded).

- **FORM-II:** It is a proforma indicating the patta numbers and extent of agricultural land owned by the **candidate / parents** duly certified by **the Tahsildar with his office seal (or)** the candidate has to upload attested photocopies of **pattadar pass book** as evidence of ownership of agricultural land (to be uploaded).
- **Form-I and Form-II** need to be filled in with the **signatures of concerned Head of Institution and concerned officials viz., Tahsildar, respectively**, along with office seal and to be uploaded. Otherwise, the claim of the candidates under this category will be summarily rejected.

Original certificates to be produced at the time of Admission:

- SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
- Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).
- Telangana State EAMCET-2020 Hall Ticket and Rank Card.
- Bonafide / Study Certificate from 6th to 12th Class.
- Transfer Certificate.
- Residential Certificate.
- The latest certified copy of the Social Status Certificate issued by the competent authority in case of applicants belonging to Backward Classes, Scheduled Castes and Scheduled Tribes.
- Non-Municipal Area Study Certificate (Form-I).
- Agricultural Land Holding Certificate (Form-II).
- Physically Challenged Certificate.
- National Cadet Corps (NCC) Certificate.
- Sports and Games Certificates.
- Children of Armed Personnel Certificate / Defence Personnel Certificate.

Important Instructions:

- All the applicants are called for counseling.
- If the candidates are not available in the said categories as indicated, such seats will be shifted to the subsequent categories as per the norms of the rule of reservation.
- Though seats are not available in certain categories, candidates belonging to such categories may also attend the counseling since there may be the possibility of rotation of seats in the event of non availability of candidates in the said categories as indicated.
- More number of candidates than availability of seats are called for Counselling and hence mere attendance / participation during counselling does not guarantee admission.
- This notification shall be treated as individual intimation. No separate intimation will be sent.
- Open Competition includes all categories viz., OC, BC, SC & ST (by merit only).
- The candidates are required to produce all the relevant original certificates at the time of counselling failing which the candidature for admission will be disqualified.
- The selected candidates will have to pay an amount of Rs. 37,110/- requisite fees including deposits immediately failing which the seat will stand cancelled.
- Fees once paid to the University shall not be refunded under any circumstances. In case of cancellation of seat, the candidate has to forfeit the fee already paid and in addition, the candidate has to pay an amount of Rs. 4,000/- (Rs. 2,000/- for SC/ST/PH) towards cancellation fees.
- Selection of candidates under BC, SC & ST quota is subject to clearance by the respective social status by the respective Directorates of Government of Telangana.
- The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.
- Candidates called for counselling shall have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate during counselling.

- The University doesn't guarantee any employment to the candidates joining the course.
- Candidates are required to read the prospectus thoroughly before attending the counselling.
- It is likely that counselling process may extend late into the evening, hence the candidates and parents/ guardians are requested to come well prepared.
- Candidates should report at the Counselling center one hour before the scheduled time.
- Certificates / documents other than those uploaded will not be entertained or considered for the allotment of seats.
- Candidates belonging to BC, SC & ST Categories should bring two sets of Xerox copies of their caste certificate to be submitted at the counselling center.
- **15% of seats in B.Tech.(Agricultural Engineering) under ICAR quota will be filled up by ICAR through the online counselling based on ranks obtained in UG-AIEEA-2020 examination conducted at national level. The seats left over under ICAR quota will not be filled up by the University.**
- **The candidates selected for admission should submit Medical fitness certificate at the time of reporting in the college.**
