The **FINAL** combined counseling for the candidates who have submitted their **ONLINE** application for admission into Bi.P.C. Stream Courses of Professor Jayashankar Telangana State Agricultural University (PJTSAU), Hyderabad, P.V. Narsimha Rao Telangana Veterinary University (PVNRTVU), Hyderabad and Sri. Konda Laxman Telangana State Horticultural University (SKLTSHU), Mulugu for the Academic Year 2020-21 viz., B.Sc.(Hons.) Agriculture / B.V.Sc.& A.H. / B.F.Sc. & B.Sc.(Hons.) Horticulture based on their Telangana EAMCET–2020 Ranks will be held at the University Auditorium, PJTSAU Campus, Rajendranagar, Hyderabad as per the schedule mentioned below:

**Note:**

- **As on 30-01-2021 the seats are available only in Farmers Quota in BC-D, SC & ST categories. Hence, candidates belonging to Non-Farmers quota are informed to visit website [www.pjtsau.edu.in](http://www.pjtsau.edu.in) before attending to the counselling on 02-02-2021. If seats are not available such candidates need not attending to the counselling.**
- **The seats if arise on the day of counselling will also be considered for filling up.**

All Categories mean that OC, BC, SC & ST's.

Reservation of seats for the candidates coming from families of Agriculturist cum Rural Area (Farmers' Quota):

- **Forty per cent (40%) of the seats in the PJTSAU & SKLTSHU and 25% in PVNRTVU are reserved for candidates coming from families of Agriculturists (Farmers) owning not less than ONE acre of land either in the name of the parents or in the name of the candidates and who have studied for a minimum of 4 years in schools located in Non-Municipal areas.**
- **If the land is owned by grandfather, grandmother or guardian or any other relations reservation is not acceptable under farmer quota.**
- **FORM-I:** It is a proforma to be certified by the **Head Master** of the School with his office seal that the candidate has studied for a **minimum period of four years in schools located in Non-Municipal areas** during their period of study from 1<sup>st</sup> class to 12<sup>th</sup> class / Intermediate (**Non-Municipal Area Certificate**).
- **FORM-II:** It is a proforma indicating the patta numbers and extent of land owned by the **candidate / parents** duly certified by the **Tahsildar with his office seal (or)** the candidate has to upload attested photocopies of **pattadar pass book** as an evidence of the extent of agricultural land.
- **Form-I and Form-II** need to be filled in with the **signatures of concerned officials viz., concerned Head of Institution and Tahsildar, respectively**, along with office seal. Otherwise, the claim of the candidates under this category will be summarily rejected.

**IMPORTANT INSTRUCTIONS: -**

- **The candidates are informed to visit University website [www.pjtsau.edu.in](http://www.pjtsau.edu.in) regularly for latest updates, especially during the days of counselling schedule for seat availability provision.**
- **In the event of non-availability of seats, under any particular category, the candidates belonging to those concerned categories are advised not to attend the counselling.**
- **For the Un-Reserved (Non-Local 15%) quota, any candidate from Telangana / Andhra Pradesh / Un-Reserved with TS EAMCET-2020 Rank can compete on the basis of merit and rule of reservation.**
- This notification shall be treated as an individual intimation and no separate intimation will be issued
- **All Categories means the candidate belonging to OC, BC, SC and ST including Non-Farmer and Farmer.**
- **The candidates need to attend the counselling on the scheduled day as per the ranks indicated above.**
- The candidates are required to produce all the relevant original certificates at the time of counselling failing which the candidature for admission will be rejected.
- **The selected candidates will have to pay the requisite fees inclusive of deposits immediately failing which the seat will stand cancelled.**
- **Hostel accommodation will be provided subject to availability.**
- **Fees once paid to the University will not be refunded under any circumstances.**
- If the admitted candidate cancels his/her seat **before the closure of admissions** for the Academic Year 2020-21 an amount of Rs. 4,000/- for General and Rs. 2,000/- for SC/ST/PH shall be collected as cancellation fee. The fees already paid during admission shall be refunded.
- **After closure of admissions process for the AY 2020-21 the candidate forfeits the fees already paid and in addition he/she has to pay cancellation fees as per the norms of the respective Universities (indicated in the fees structure).**
- Selection of candidates under BC, SC & ST quota is subject to clearance of the respective social status by the respective Directorates of Government of Telangana.
- **The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.**
- Candidates called for counselling will have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate during the counselling process.
- **The Universities do not guarantee any employment to the candidates joining the courses.**
- Candidates are required to read the prospectus thoroughly before attending the counselling.
- The counseling process is likely to extend late into the evening; hence the candidates and parents/ guardians are requested to come well prepared for the same.
- **More number of candidates than the availability of seats are called for counseling and hence, mere attendance / participation during counselling does not guarantee admission.**
- Candidates should report at the counselling center one hour before the scheduled time.
- **Certificates / documents other than those uploaded will not be entertained or considered for the allotment of seats.**
- Candidates belonging to BC, SC & ST categories should bring two Xerox copies of their caste certificate to be submitted at the counselling center.
- **The seats reserved under BC/SC/ST categories including farmers quota shall also be filled up simultaneously during the counseling process on the scheduled days.**
- Out of total seats 36% in B.F.Sc. UG programme (*i.e.*, 11 seats) offered by Sri Venkateswara Veterinary University (SVVU), Tirupati, Andhra Pradesh are earmarked for Telangana State. The admission is based on the Rank obtained in TS EAMCET-2020. The candidates selected under these seats will be required to study at College of Fishery Science, Muthukur, Nellore Dist. under the control of SVVU. The fee structure as prescribed by SVVU is approximately Rs. 37,000/-.
- **A candidate for admission under general category to B.V.Sc. & A.H. degree course, must have passed in the subjects of English, Physics, Chemistry & Biology and obtained 50% (45% for SC/ST/PH category) of marks at the intermediate level in each subject.**
- **The candidates who did not attend the first counselling may attend the second counselling.**

- Sliding and shifting from one course to another course and one college to another college will be done based on the merit and rule of reservation and availability of seats.
- During the sliding process opted by the candidates from one college to another college or one course and another course a few seats may arise in the categories which are not mentioned in the seat availability position.
- In the event of sliding from one course to another course and one college to another college the candidates need to pay the differential amounts of fees as per the fee structure of the respective Universities.
- 15% of seats in B.Sc. (Hons.) Agriculture under ICAR quota will be filled up based on ranks obtained in UG-AIEEA-2020 National level examination conducted by ICAR. **The left over seats under ICAR quota will not be filled up by the University.**
- **In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned.**
- The University is not responsible for any information provided in websites other than at [www.pjtsau.edu.in](http://www.pjtsau.edu.in).
- **Parents and Students are informed that the admissions are purely based on merit and guidelines of the University and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into PJTSAU under any quota. All the seats will be filled by the University only through combined counselling.**
