\* All the eligible applicants under Agribusiness Management MBA(ABM) are informed to attend Group Discussion followed by Personal Interview at 9:00 AM on 15-12-2023 at Committee Hall, Knowledge Management Centre (University Central Library), PJTSAU, Rajendranagar. The Merit List shall be prepared based on the performance

in Group Discussion & Personal Interview and counselling of such candidates shall be conducted at 2:00 PM in University Auditorium Rajendranagar, Hyderabad on the same day.

- This Notification shall be treated as an individual intimation.
- As per the eligibility criteria, candidates seeking admission into Master's Degree courses and Doctoral Degree Courses must have passed the relevant courses from accredited institutions by ICAR. Hence, applicants are informed to produce proof of accreditation certificates of their institutions (University, College and Course) concerned without fail for consideration of their admission into the courses concerned.
- The applicants are informed that Merit list is provisional / tentative and it is prepared based on the information submitted by the applicants through online application form.
- The applicants are informed that mere appearing his/her name in the merit list does not guarantee the admission and cannot claim the eligibility.
- The candidature for admission shall be based on the eligibility criteria as specified in the Prospectus of the University. The admission into PG and Ph.D. courses is subject to production of accreditation certificates by the candidates at the time of Counselling.
- The candidates are required to produce all the relevant original certificates along with **two sets of online applications forms and two passport size photos at the time of counselling** failing which the candidature for admission will be disqualified.
- The selected candidates will have to pay the requisite fees including deposits immediately failing which the seat will stand cancelled (as mentioned in the Prospectus).
- Selection of candidates under EWS, BC, SC & ST quota is subject to clearance of the social status by the respective officials from the respective Directorates of Government of Telangana.
- The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.
- Candidates called for counselling shall have to attend at their own cost.
- The University doesn't guarantee any employment to the candidates joining the course.
- Candidates are required to read the prospectus thoroughly before attending the counselling and ensure that he / she has fulfilled the eligibility criteria for admission into courses concerned as per ICAR guidelines.
- It is likely that counselling process may extend late in the evening, hence the candidates and parents / guardians are requested to come well prepared.
- More number of candidates than availability of seats are called for counselling and hence mere attendance / participation during counselling does not guarantee admission.
- Candidates should report at the counselling centre one hour before the scheduled time.
- Candidates belonging to EWS, BC, SC & ST categories should bring **two sets of Xerox copies of** their caste certificate to be submitted at the counselling centre.
- The candidates selected for admission should submit Medical fitness certificate at the time of reporting in the college.
- In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned
- Hostel facility will be provided subject to the availability
