- The officers of Directorate of Sainik Welfare will verify the original certificates of the candidates and indicate the priorities.
- The candidates are informed to bring their latest CAP certificates for verification.
- A total intake of 2% in each UG Degree Programme are reserved for the Children of Armed Persons i.e. Ex-Servicemen, Defence Personal including the children of Boarder Security Forces and Central Reserved Force who are domiciled in Telangana State based on the Permanent Address / Home Town declared by them while joining the service and as recorded in the Service Registers (G.O.Ms.No.22, dt. 20-7-2015 of Principal Secretary to Government, Higher Education Department).
- The selected candidates will have to pay the requisite fees including deposits immediately as given in the prospectus for General and Self-financing seats, failing which the seat will stand cancelled.
- **The candidates are required to bring TWO sets of online application with all enclosures along with original certificates for verification.**
- **Based on the priorities allocated by the CAP officials, seats shall be filled up as per ranks obtained in the Telangana EAMCET-2023 and duly following the rule of reservation.**
- **Based on the ranks obtained in the AGRICET-2023 and rule of reservation the seats in B.Sc.(Hons.) Agriculture will be filled up for the Diploma holders.**
- **Candidates are informed to read the prospectus thoroughly for the eligibility & selection criteria and other rules laid down before attending the certificate verification and counselling.**
- The Candidates are informed to attend the certificate verification and counseling one hour before the scheduled time.

In the reference 1<sup>st</sup> read above, the Government of Andhra Pradesh have issued Admission Rules for admissions to be made into Under Graduate Professional Courses i.e., the Andhra Pradesh Professional Educational Institutions (Regulation of Admissions of Engineering / Pharmacy Diploma Holders into Under Graduate Professional Courses through Common Entrance Test) Rules, 2006.

3. Accordingly, the following Notification will be published in the Extraordinary Issue of the Telangana State Gazette, dt.21.07.2015

**NOTIFICATION**

In exercise of the powers conferred by sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983, (Act No.5 of 1983), Government hereby make the following amendments to the Telangana Professional Educational Institutions (Regulation of Admissions of Engineering / Pharmacy Diploma holders into Under Graduate Professional Courses through Common Entrance Test) Rules, 2006 issued in G.O.Ms.No.61, Higher Education (EC) Department, dated 26.05.2006 and as subsequently amended from time to time.

**AMENDMENTS**

In rule 7 (iii) of the said rules under the sub heading "(I) Reservation for Special Categories, clause (2), the following shall be substituted, namely;-

"(2)Children of Armed Forces (CAP) - 2% (two percent) for the children of armed persons i.e., Ex-Servicemen, Defence
