- The candidates seeking admission under Self-financing quota seats may note the following:
 The applicant seeking admission in B.Sc. (Hons.) Agriculture under Self Financing quota, should bring
- DD for an amount Rs. 2,54,450.00 in favor of "The Comptroller, PJTSAU" payable at Hyderabad.
- If the applicant gets an admission in B.Sc. (Hons.) Agriculture under Self Financing quota he/she has to submit the **DD for Rs. 2,54,450.00** and pay **Rs. 45,550.00 in cash.**
- If the applicant gets an admission in B.Sc. (Hons.) Horticulture under Self Financing quota he/she has to submit the DD for Rs. 2,54,450.00 and pay **Rs. 27,745.00 in cash**.
- The candidates admitted under this quota are not eligible for any reimbursement of fee or educational concessions offered by the Government. The candidates who will bring the Demand Draft as indicated above are only eligible to attend to the counselling under self-financing quota.
- The Demand Draft should be taken from the Bank Account of the candidate or parent ONLY and in the event of cancellation of the Self-financing seat, the fees shall be refunded through a cheque issued either on the name of student or parent, duly deducting the cancellation fees of Rs. 5,000/-.
- The rules and regulations with regard to eligibility, age, reservations etc., are the same that are applicable to the candidates admitted under general quota.
- The candidates selected under self-financing quota will be treated on par with regular students. No special amenities or facilities will be provided.
- The unfilled seats under self-financing quota will not be filled up from any other stream and will be kept vacant.

- **Priority 2**: The seats shall be **filled-up by the non-applicants** based on the ranks obtained by the candidates under Agriculture and Medical Stream in the TS-EAMCET-2023.
- **Priority 3**: The vacant unfilled seats in B.Sc. (Hons.) Agriculture course under TS-EAMCET-2023 quota if any, shall be filled-up by the diploma candidates **based on the ranks obtained in PJTSAU-AGRICET-2023 examination.**

Hence, all the applicants of all categories (OC, BC-A, BC-B, BC-C, BC-D, BC-E, SC & ST) may attend the counselling.

- The selected candidates under AGRICET are also informed to pay an amount of Rs.1800/- (Rs.900/- in respect of SC/ST/PH) candidates towards the registration fee immediately.

- For the Un-Reserved (Non-Local 15%) quota, any candidate from Telangana / Andhra Pradesh / Un-Reserved with PJTSAU-AGRICET-2023 Rank can compete on the basis of merit and rule of reservation.
- > Hostel accommodation will be provided subject to availability.
- If the admitted candidate cancels his/her seat before the closure of admissions for the Academic Year 2023-24 an amount of Rs.5,000/- shall be collected as processing fee. The remaining fees already paid during admission shall be refunded.
- After closure of admissions process for the AY 2023-24 the candidate forfeits the fees already paid and in addition he/she has to pay cancellation fees as per the norms.
- Selection of candidates under BC, SC & ST quota is subject to clearance of the respective social status by the respective Directorates of Government of Telangana.
