All the applicants under NCC category in the above Major Subjects are advised to report to the O/o Controller of Examinations, Examinations Centre, Rajendranagar, Hyderabad on 14-11-2024 at 10.00 AM with all their original certificates, Passport size photos (2 sets) and prescribed fee as given in the Information Booklet.

Reservation of seats under 1% NCC quota:

The NCC quota shall be as prescribed in the PG admissions as per the priorities specified in the Government Order.

- Such seats shall be within the intake capacity only, but not supernumerary and shall be allotted as per the procedure followed for other reservations.
- The NCC quota as prescribed may be implemented, by reserving seats among various departments by following the roster system [comparing weightage (number of seats) for major field of study in the decreasing order and in case of same weightage, alphabetical order of major field of study will be followed for seat allotment].
- If no NCC candidates are available in the reserved major field of study, such vacant seat shall be filled with a non-NCC candidate of the same category in the same major field of study where the seat has been reserved for NCC.
- If the seats remain still vacant, they shall be filled-up as per the rule of reservation within the same major field of study only.

If still further vacancy arises, the vacant seats will not be filled by the NCC candidates who appeared for the entrance exam in other major field of study

- As per the eligibility criteria, candidates seeking admission into PG courses must have passed the relevant UG and PG courses from accredited institutions by ICAR. Hence, applicants are informed to produce proof of accreditation certificates of their College & University concerned without fail for consideration of their admission into the courses concerned.
- This information shall be treated as an individual intimation.
- The applicants are informed that mere appearing his/her name in the list above does not guarantee the admission and cannot claim the eligibility.
- The candidature for admission shall be based on the eligibility criteria and all other guidelines as specified in the Information Booklet of the University.
- The selected candidates will have to pay the requisite fees including deposits immediately failing which the seat will stand cancelled.
- Candidates called for scrutiny and verification of application shall have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate.
- The University doesn't guarantee any employment to the candidates joining the course.
- Candidates are required to read the Information Booklet thoroughly before attending the verification process and ensure that he / she has fulfilled the eligibility criteria for admission into courses concerned as per ICAR guidelines.
- The candidates selected for admission should submit Medical fitness certificate at the time of reporting in the college.
- In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned
