The 307th meeting of the Board of Management of PJTAU (Hybrid Mode) held on 16.12.2024 vide Resolution No.885 have approved guidelines for grant of deputation for faculty to pursue Ph.D. program and Academic Performance Score (APS) for selection of In-Service faculty for Admission into Ph.D. under In-Service Quota from the A.Y.2024-25. Therefore applications are invited in continuation to the notification issued vide ref.(2) cited from the eligible in-service ICAR Teachers/Scientists/Technical Staff in subject of their choice nominated by ICAR Institutes for the Academic Year 2024-25 for admission for prosecuting Ph.D. (Ag) for the A.Y.2024-25, as detailed below:

Qualifications: Master's Degree in the concerned faculty and major field with a minimum of 50% marks in traditional system or OGPA of 7.50 / 10.00 or 3.25/4.00. SC/ST candidates with a pass in traditional system or OGPA of 7.00/10.00 or 3.00/4.00 are eligible. Basic degree i.e. B.Sc.(Ag) or B.Sc. (Home Science) as the case may be in the concerned faculty is essential.

Age: The upper age limit is 45 years of age as on 31-12-2024
(relaxable by 5 yrs for women/SCs/STs)

Service: Minimum of 3 years of regular service and whose probation is declared.

- Criteria for Selection:** The selection shall be based on the following Academic Performance Score (APS) No marks shall be awarded up to three (03) years of service.
- Above three (03) years, one (01) mark shall be awarded for every one year with a maximum of five (05) marks.

3. For publications in the relevant field of discipline only, the following criteria shall be followed with maximum of five (05) Marks.



4. The candidates who are having externally funded projects including NABARD / RKVY as first or second *i.e.*, Principal Investigator or Co Principal Investigator with a project outlay of above 5 lakhs shall be awarded 2.0 Marks and 1.0 mark shall be awarded for every 5 lakhs with a maximum of 5.0 marks under this category.
5. Candidates having "Outstanding Performance" in their confidential report shall be awarded 1.0 mark for each year to a maximum of 5.0 marks.
6. In case of tie for selection of candidates, job seniority followed by date of birth shall be considered.

Submission of Application: The in-service candidate should submit their applications in the proforma (Annexure) along with copies of certificates *i.e.* B.Sc. and M.Sc. degree in the concerned faculty along with all proofs to their respective Heads of Offices well in advance so as to enable them to verify the particulars furnished in the applications and forward them through proper channel so as to reach the Registrar, Professor Jayashankar Telangana Agricultural University, Rajendranagar, Hyderabad-500 030, on or before 20.01.2025 by 4.00 PM in an envelope super scribed as "Application for Admission into Ph.D. under in-service quota". To avoid delay the advance copy shall be sent so as to reach the Registrar, PJTAU, Rajendranagar, Hyderabad, before the due date. Endorsement of the Head of Office at the space provided in the Application is sufficient and separate covering letter is not required. The Heads of Institutions/Offices are requested to bring this to the notice of all concerned/display in the notice board and also to ensure that the applications submitted by the candidates are promptly forwarded so as to reach the University before the prescribed date.
