**Note:**

- **As this is a Spot counselling (Mop Up), if candidates of one particular social category are not available for admission, such seats will be shifted to another social category as per the rule of reservation. Hence, all the applicants of all categories (OC, EWS, BC-A, BC-B, BC-C, BC-D, BC-E, SC & ST) may attend the counselling.**
- **The vacant seats if any, arise even on the day of the counselling will also be considered and filled up along with the seats as notified above.**

**Original certificates to be produced:**

The selected candidates for admission, should pay the fees immediately and submit the following certificates *in Original*.

- Pass Certificate-cum-Memorandum of Marks obtained by the candidates in the qualifying examination (Diploma in Agricultural Engineering)
- SSC or equivalent examination certificate.
- The Caste certificate in case of the candidates belonging to Backward Classes, Scheduled Castes and Scheduled Tribes, signed by the competent authority.
- Bonafide or Study certificates.

- v) Residence Certificate, if necessary.
- vi) Transfer Certificate from the College or School where the candidate last studied.
- vii) Physical fitness certificate.
- viii) The latest certified copy of the EWS Certificate valid for the year 2024-25 issued by the competent authority in case of the applicants belonging to EWS category.

- The **hostel and mess** charges are additional/extra for both Regular and Self-Financing Seats.

**The candidates seeking admission under Self-Financing quota seats for B.Tech. (Agricultural Engineering) course may note the following:**

- The candidates attending the counselling under Self Financing quota should bring a demand draft of Rs. 2,53,450/- (Rupees two lakhs fifty three thousand four hundred and fifty only) in favour of “**THE COMPTROLLER, PJTSAU**” payable at **Hyderabad** and Rs. 46,550/- (Rupees forty six thousand five hundred and fifty only) in cash for immediate payment at college allotted.
- The rules and regulations with regard to eligibility, age, reservations etc., are the same that are applicable to the candidates admitted under general quota.
- The candidates selected under self-financing quota will be treated on par with regular students. No special amenities or facilities will be provided.
- The unfilled seats under self-financing quota will not be filled up with the candidates any other stream and will be kept vacant.
- The candidates admitted under this quota are not eligible for any reimbursement of fee or educational concessions offered by the Government.

**Important Instructions:**

- The selected candidates should submit all original certificates and shall pay the requisite fee (in cash) after the seat allotment.
- **Hostel accommodation will be provided subject to availability.**
- **If the admitted candidate cancels his/her seat before the closure of admissions for the Academic Year 2024-25 an amount of Rs.1,000/- shall be collected as processing fee. The remaining fees already paid during admission shall be refunded.**
- **After closure of admissions process for the AY 2024-25 the candidate forfeits the fees already paid and in addition, he/she has to pay processing fee.**
- Selection of candidates under EWS, BC, SC & ST quota is subject to clearance of the respective social status by the respective Directorates of Government of Telangana.
- **The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.**
- Candidates called for counselling will have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate during the counselling process.

- **The University does not guarantee any employment to the candidates joining the course.**
- **More number of candidates than the availability of seats is called for counselling and hence, mere attendance / participation during counselling does not guarantee admission.**
- Candidates should report at the counselling center one hour before the scheduled time.
- Candidates belonging to EWS, BC, SC & ST categories should bring two Xerox copies of their relevant certificates to be submitted at the counselling center.
- The University is not responsible for any information provided in websites other than at [www.pjtsau.edu.in](http://www.pjtsau.edu.in).
- **Parents and Students are informed that the admissions are purely based on merit and guidelines of the University and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into PJTAU under any quota. All the seats will be filled by the University only through counselling.**
- **The selected candidates are advised to take mobile numbers of the concerned officers of the allotted college for official information.**
- **Candidates are informed to attend counselling on the scheduled date and time. If they fail to attend, they cannot claim the seat as per merit.**
- **Candidates, if attend the counselling late, they will have to submit the letter to the counselling authorities duly indicating the time of their attending the counselling.**
