- As this a Mop Up round, if candidates belonging to Farmers quota are not available for admission, such seats shall be shifted to Non-Farmers quota within the same social category.**
- If still further vacant seats are available and if candidates of one particular social category are not available for admission, such seats will be shifted to another social category as per the rule of reservation. Hence, all the applicants of all categories (OC, BC-A, BC-B, BC-C, BC-D, BC-E, SC, ST & EWS - Both Rural, Non-Rural, FARMERS & NON-FARMERS) may attend the counselling.**
- If any candidate cancels his/her seat after this Final SPOT (MOP-UP) round, the candidate shall forfeit the fees already paid and in addition he/she has to pay cancellation fees as per the norms of the respective Universities.**

IMPORTANT INSTRUCTIONS: -

- **As this is the final counselling to be notified, if any further vacancies arise, the attendance of the applicants of this counselling shall only be considered based on merit and rule of reservation.**
- **If any candidate cancels his/her seat after this Final SPOT (MOP-UP) round, the candidate shall forfeit the fees already paid and in addition he/she has to pay cancellation fees as per the norms of the respective Universities.**
- All the candidates are informed to visit the website (www.pjtsau.edu.in) for seat availability position before attending the counselling, which will be updated regularly during the counselling days.
- Vacancies if any arise, even on the date of the counselling also will be considered for admission process. Candidates are required to read the prospectus thoroughly before attending the counselling.
- During the sliding process opted by the candidates from one college to another college or one course and another course a few seats may arise in the categories which are not mentioned in the seat availability position.
- The candidates who secured admission in the previous phase are also eligible for subsequent phases of counselling for better course or better college preferred by him/her. For each phase of counselling separate notification will be given for which candidates need not apply again.
- **The following candidates are eligible for the counselling:**
 - **Who secured a seat in earlier phase of counseling and wish to move to some other colleges as per their merit and rule of reservation**
 - **Candidates who participated in earlier phase of counseling and could not secure a seat.**
 - **Candidates who did not participate in the earlier phase.**
 - **Candidates who were allotted a seat but didn't report/pay the fee at the college.**
 - **A candidate allotted a seat in earlier phase but cancelled his/her admission.**
 - All the candidates are informed to visit the website (www.pjtsau.edu.in) for seat availability position before attending the counselling, which will be updated regularly during the counselling days.
 - Vacancies if any arise, even on the date of the counselling also will be considered for admission process. Candidates are required to read the prospectus thoroughly before attending the counselling.

 - **All the candidates are informed to visit the website(www.pjtsau.edu.in) for seat availability position before attending the counselling.**
 - **For the Un-Reserved (@15%) quota, any candidate from Telangana / Andhra Pradesh / Un-Reserved with TS EAPCET-2024 Rank can compete on the basis of merit and rule of reservation.**
 - This notification shall be treated as an individual intimation and no separate intimation will be issued
 - **All Categories means the candidate belonging to OC, EWS, BC, SC and ST including Non-Rural, Rural, Non-Farmer and Farmer.**
 - **The candidates need to attend the counselling on the scheduled day as per the ranks indicated.**
 - The candidates are informed that the duration of B.V.Sc. & A.H. course is of 5 ½ years as per the recent regulations of Veterinary Council of India, New Delhi. The pattern of education for B.V.Sc. & A.H. course shall be on annual system basis.

- The candidates are required to produce all the relevant original certificates at the time of counselling failing which the candidature for admission will be rejected.
- **The selected candidates will have to pay the requisite fees inclusive of deposits (in cash) immediately failing which the seat will stand cancelled.**
- Selection of candidates under EWS, BC, SC & ST quota is subject to clearance of the respective social status by the respective Directorates of Government of Telangana.
- **The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.**
- Counselling is held manually, not online counselling.
- Candidates called for counselling will have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate during the counselling process.
- **The Universities do not guarantee any employment to the candidates joining the courses.**
- The counseling process is likely to extend late into the evening; hence the candidates and parents/guardians are requested to come well prepared for the same.
- **More number of candidates than the availability of seats are called for counseling and hence, mere attendance / participation during counselling does not guarantee admission.**
- Candidates should report at the counselling center one hour before the scheduled time.
- Candidates belonging to EWS, BC, SC & ST categories should bring two Xerox copies of their relevant certificate to be submitted at the counselling center.
- **The seats reserved under EWS/BC/SC/ST categories including farmers quota shall also be filledup simultaneously during the counseling process on the scheduled days.**
- A candidate for admission under general category to **B.V.Sc. & A.H.** degree course, must have passed in the subjects of English, Physics, Chemistry & Biology and obtained 50% (45% for SC/ST/PH category) of marks at the intermediate level in each subject.
- Sliding and shifting from one course to another course and one college to another college will be done based on the merit and rule of reservation and availability of seats.
- In the event of sliding from one course to another course and one college to another college the candidates need to pay the differential amounts of fees as per the fee structure of the respective Universities.
- **In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate legal action against the individuals concerned.**
- The University is not responsible for any information provided in websites other than at www.pjtsau.edu.in.
- Parents and Students are informed that the admissions are purely based on merit and guidelines of the University and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into PJTAU under any quota. All the seats will be filled by the University only through combined counselling.
- **The candidates may take original certificates on request by furnishing an undertaking, if they have any other counsellings to be attended and return the certificates after the stipulated day. If they fail to return the certificates to the college, the admission shall stand cancelled. No correspondence in this regard will be entertained.**
- **The selected candidates are advised to take mobile numbers of the concerned officers of the allotted college for official information.**
- **Candidates are informed to attend counselling on the scheduled date and time. If they fail to attend, they cannot claim the seat as per merit.**
- **Candidates, if attend the counselling late, they will have to submit the letter to the counselling authorities duly indicating the time of their attending the counselling.**
