The **SPOT** (**MOP-UP**) combined counseling for the candidates who have submitted their ONLINE application for admission into Bi.P.C. Stream Courses of Professor Jayashankar Telangana Agricultural University (PJTAU), Hyderabad, P.V. Narsimha Rao Telangana Veterinary University (PVNRTVU), Hyderabad and Sri. Konda Laxman Telangana State Horticultural University (SKLTGHU), Mulugu for the Academic Year 2024-25 *viz.*, B.Sc. (Hons.) Agriculture / B.Sc. (Hons.) Community Science / B.Tech. (Food Technology) / B.V.Sc. & A.H. / B.F.Sc. / B.Sc. (Hons.) Horticulture based on their Telangana EAPCET–2024 ranks will be held at the University Auditorium, PJTAU Campus, Rajendranagar, Hyderabad as per the schedule mentioned below:

Note:

- 1. Before attending the counselling, the parents and candidates should visit the University website www.pjtsau.edu.in regularly for information pertaining to seat availability position in various categories..
- 2. Vacancies if any arise, even on the date of the counselling also will be considered for admission process.
- 3. As this a Mop Up round, if candidates belonging to Farmers quota are not available for admission, such seats shall be shifted to Non-Farmers quota within the same social category.
- 4. If still further vacant seats are available and if candidates of one particular social category are not available for admission, such seats will be shifted to another social category as per the rule of reservation. Hence, all the applicants of all categories (OC, BC-A, BC-B, BC-C, BC-D, BC-E, SC, ST Both Rural, Non-Rural, Farmers & Non-Farmers) may attend the counselling.

Reservation of seats for the candidates coming from families of Agriculturist cum Rural Area(Farmers' Quota):

- Forty per cent (40%) of the seats in the PJTAU & SKLTGHU and 25% in PVNRTVU are reserved for candidates coming from families of Agriculturists (Farmers) owning not less than ONE acre of land either in the name of the parents or in the name of the candidate and who have studied for a minimum of 4 years in schools located in Non-Municipal areas.
- > If the land is owned by grandfather, grandmother or guardian or any other relations, reservationis not acceptable under farmers' quota.
- To claim the seat under Farmers Quota both ANNEXURE I & II are mandatory.
- ANNEXURE-I: It is a proforma to be certified by the Head Master of the School with his office seal that the candidate has studied for a minimum period of four years in schools located in Non-Municipal areas during their period of study from 1st class to 12th class / Intermediate (Non-Municipal Area Certificate).
- ANNEXURE -II: It is a proforma indicating the patta numbers and extent of land owned by the candidate / parents duly certified by the Tahsildar with his office seal (or) the candidate has to furnish the ORIGINAL pattadar pass book as an evidence of the extent of agricultural land.
- NNEXURE -I and ANNEXURE -II need to be filled in with the signatures of concerned officialsviz., concerned Head of Institution and Tahsildar, respectively, along with office seal. Otherwise, the claim of the candidates under this category will be summarily rejected.

No ONLINE / UPI transactions are accepted.

- > The **hostel and mess** charges are additional/extra.
- ➤ Hostel accommodation will be provided subject to availability.

Original certificates to be produced at the time of counselling:

- a) Online Application Form.
- b) SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
- c) Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).
- d) Telangana EAPCET-2024 Rank Card.
- e) Bonafide / Study Certificate from 6th to 12th Class.
- f) Non-Municipal Area Study Certificate (ANNEXURE-I) (At least four years of the study periodbefore the qualifying examination), if applicable.
- g) Agricultural Land Holding Certificate (ANNEXURE-II) (At least one acre farm land), ifapplicable or ORIGINAL pattadar pass book
- h) The certified copy of the Social Status (Caste) Certificate issued by the competent authority incase of applicants belonging to Backward Classes, Scheduled Castes and Scheduled Tribes.
- i) The certified copy of the EWS Certificate issued for the year 2024-25 by the competent authority in case of applicants belonging to EWS.
- j) If the candidate has joined in any of the college of PJTAU, PVNRTVU & SKLTGHU during the previous phases of allotment he/she has to submit the following documents:
 - i. Copy of Admission letter.
 - ii. Custodian certificate of the institute joined.
 - iii. Fee receipt of the respective college.

IMPORTANT INSTRUCTIONS: -

- ➤ The following candidates are eligible for the counselling:
 - Who secured a seat in earlier phases (Regular/Special Quota) of counseling and wish to move to some other colleges as per their merit and rule of reservation
 - Candidates who participated in earlier phases (Regular/Special Quota) of counseling and could not secure a seat.
 - Candidates who did not participate in the earlier phase.
 - Candidates who were allotted a seat but didn't report/pay the fee at the college.
 - A candidate allotted a seat in earlier phase but cancelled his/her admission.
- All the candidates are informed to visit the website (www.pjtsau.edu.in) for seat availability position before attending the counselling.
- Vacancies if any arise, even on the date of the counselling also will be considered for admission process. Candidates are required to read the prospectus thoroughly before attending the counselling.
- During the sliding process opted by the candidates from one college to another college or one course and another course a few seats may arise in the categories which are not mentioned in the seat availability position.
- The candidates who secured admission in the previous phases (Regular/Special Quota) are also eligible for counselling.
- All the candidates are informed to visit the website (www.pjtsau.edu.in) for seat availability position before attending the counselling.
- Candidates are required to read the prospectus thoroughly before attending the counselling.
- The parents and candidates should visit the University website <u>www.pitsau.edu.in</u> regularly for updates and the availability of seats under various categories.
- For the Un-Reserved (@15%) quota, any candidate from Telangana / Andhra Pradesh / Un-Reserved with TG EAPCET-2024 Rank can compete on the basis of merit and rule of reservation.
- This notification shall be treated as an individual intimation and no separate intimation will be issued
- All Categories means the candidate belonging to OC, EWS, BC, SC and ST including Non-Rural, Rural, Non-Farmer and Farmer.
- The candidates are informed that the duration of B.V.Sc. & A.H. course is of 5 ½ years as per the recent regulations of Veterinary Council of India, New Delhi. The pattern of education for B.V.Sc. & A.H. course shall be on annual system basis.
- The candidates are required to produce all the relevant original certificates at the time of counselling failing which the candidature for admission will be rejected.
- The selected candidates will have to pay the requisite fees inclusive of deposits (in cash), failing which the seat will stand cancelled.
- If the admitted candidate cancels his/her seat before the closure of admissions for the Academic Year 2024-25 an amount of Rs. 1,000/- shall be collected as processing fee. The remaining fees already paid during admission shall be refunded.
- After closure of admissions process for the AY 2024-25 the candidate forfeits the fees already paid and in addition, he/she has to pay processing fees as per the norms of the respective Universities (indicated in the fees structure).
- Selection of candidates under EWS, BC, SC & ST quota is subject to clearance of the respective social status by the respective Directorates of Government of Telangana.

- The guidelines issued by Government of Telangana from time to time shall be followed scrupulously.
- Counselling is held manually, not online counselling.
- Candidates called for counselling will have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate during the counselling process.
- ➤ The Universities do not guarantee any employment to the candidates joining the courses.
- The counseling process is likely to extend late into the evening; hence the candidates and parents/guardians are requested to come well prepared for the same.
- More number of candidates than the availability of seats are called for counseling and hence, mere attendance / participation during counselling does not guarantee admission.
- Candidates should report at the counselling center one hour before the scheduled time.
- ➤ Candidates belonging to EWS, BC, SC & ST categories should bring two Xerox copies of their relevant certificate to be submitted at the counselling center.
- The seats reserved under EWS/BC/SC/ST categories including farmers quota shall also be filled up simultaneously during the counseling process.
- A candidate for admission under general category to B.V.Sc. & A.H. degree course, must have passed in the subjects of English, Physics, Chemistry & Biology and obtained 50% (45% for SC/ST/PH category) of marks at the intermediate level in each subject.
- > Sliding and shifting from one course to another course and one college to another college will be done based on the merit and rule of reservation and availability of seats.
- > In the event of sliding from one course to another course and one college to another college the candidates need to pay the differential amounts of fees as per the fee structure of the respective Universities.
- > In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate legal action against the individuals concerned.
- The University is not responsible for any information provided in websites other than at www.pjtsau.edu.in.
- > Parents and Students are informed that the admissions are purely based on merit and guidelines of the University and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into PJTAU under any quota. All the seats will be filled by the University only through combined counselling.
- > The candidates may take original certificates on request by furnishing an undertaking, if they have any other counsellings to be attended and return the certificates after the stipulated day. If they fail to return the certificates to the college, the admission shall stand cancelled. No correspondence in this regard will be entertained.
- The selected candidates are advised to take mobile numbers of the concerned officers of the allotted college for official information.
- > Candidates are informed to attend counselling on the scheduled date and time. If they fail to attend, they cannot claim the seat as per merit.
- Candidates, if attend the counselling late, they will have to submit the letter to the counselling authorities duly indicating the time of their attending the counselling.
