**Instructions to allotted candidates for admission into various Under Graduate courses of  
PJ TSAU (B.Sc. (Hons.) Agriculture & B.Sc. (Hons.) Community Science), P VNRTVU  
(B.V.Sc. & A.H. & B.F.Sc.) and SKLTSHU (B.Sc. (Hons.) Horticulture) for the AY 2021-22**

1. Applicants are requested to visit the University's website: [www.pjtsau.edu.in](http://www.pjtsau.edu.in) frequently for regular updates regarding admission and counselling process. **No** special information, SMS, mail or intimation will be sent to the candidate.
2. Based on the option exercised by the applicants and availability of seats in each course, final allotment of seats are made as per the reservation policy and the same is put up on the University website ([www.pjtsau.edu.in](http://www.pjtsau.edu.in)).
3. Candidates are informed to check their final allotment from the website [www.pjtsau.edu.in](http://www.pjtsau.edu.in) and report to the respective college allotted on **04-04-2022, 06-04-2022 to 07-04-2022 by 05:00 PM** along with all original certificates and shall pay the fee as specified in the prospectus, failing which the admission shall stand cancelled (**The details of the colleges and contact persons are appended at the end**).
4. **The fee particulars of U.G. Programmes of three Universities are as follows:**

5. If the candidate is selected under Farmers' quota, he/she should submit original **ANNEXURE-I** (Non-municipal certificate for a minimum period of four years) & **ANNEXURE-II** (Extent of farm land not less than 1 acre) without fail as per the norms.
6. The selected candidate should produce the following original certificates along with the Two sets of xerox copies.
  - a) Online Application Form.
  - b) SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
  - c) Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).

- d) Telangana State EAMCET-2021 Rank Card.
- e) Bonafide / Study Certificate from 6<sup>th</sup> to 12<sup>th</sup> Class.
- f) Non-Municipal Area Study Certificate (ANNEXURE-I) (At least four years of the study period before the qualifying examination), if applicable.
- g) Agricultural Land Holding Certificate (ANNEXURE-II) (At least one acre farm land), if applicable.
- h) The latest certified copy of the Social Status (Caste) Certificate issued by the competent authority from Telangana State in case of applicants belonging to Backward Classes, Scheduled Castes and Scheduled Tribes.
- i) The latest certified copy of the EWS Certificate issued for the year 2021-22 by the competent authority from Telangana State in case of applicants belonging to EWS.
- j) Four latest passport size photographs of the student.
- k) If the candidate has joined in any of the college of PJTSAU, PVNRTVU & SKLTSHU during the previous phase of allotment he/she has to submit the following documents:
  - i. Copy of Admission letter.
  - ii. Custodian certificate of the institute joined.
  - iii. Fee receipt of the respective college.
- 7. If the candidates want to attend counselling for other courses of other Universities, he/she may request (duly submitting the undertaking) the college Associate Dean to issue a custodian certificate OR arrange the original certificates to be submitted back within the stipulated time. If the original certificates are not returned to the Associate Dean of the college within the stipulated time, the admission shall stand cancelled and the seat shall be filled up in the subsequent phases of counselling.
- 8. If the candidate does not join the allotted college within the prescribed date his/her seat will be automatically cancelled. Hence, after seat allotment, the candidate has to join the college within the prescribed date and time. No correspondence in this regard will be entertained.
- 9. The verification of all the documents in accordance with the eligibility criteria of the course will be done by the Officers of the allotted college.
- 10. The Community certificates of the candidates have already been certified by the concerned Welfare Officers. Hence, No need to be verified again at College level.
- 11. The selected candidates in these phases are eligible for other phases of counselling also for better course or better college. For each phase of counselling separate notification will be given for exercising the options. Option exercised in this phase can't be considered for the subsequent phases. Hence the candidates are informed to regularly visit the University website- [www.pjtsau.edu.in](http://www.pjtsau.edu.in) for counselling notification.

**NOTE:**

- **If the candidate has secured a seat in the previous phase and if he/she secures seat in the fifth phase based on his merit and option, he/she should report at the newly allotted college within the stipulated time otherwise the seat secured in the previous phase and this phase both shall stand cancelled.**
  - Candidates have to exercise options afresh for each phase of counseling.
  - Options may be exercised for those colleges even if the vacancies are not available, because vacancies may arise due to sliding, cancellation and conversions of candidates from one college to another college.
12. The following candidates are eligible for subsequent phases:
- Who secure a seat in earlier phase of online counseling and wish to move to some other colleges.
  - Candidates who participated in earlier phase of online counseling and could not secure a seat.
  - Candidates who did not participate in earlier phase.
  - Candidates who were allotted a seat but didn't report/pay the fee at the college.
  - A candidate allotted a seat in earlier phase but cancelled his/her admission.
13. If the candidate secures a seat in this Phase, he/she will loose the claim on the earlier allotted college, and has to report to the new college by downloading the list of provisionally selected candidates during the phase concerned before the date furnished. Failing to report to the new college within the date furnished, he/she will loose the claim on the new college as well as the old college.
14. In case the candidates wish to cancel their admission, he/she shall approach the Associate Deans of the college concerned only but not to the authorities of the University.
15. **If the admitted candidate cancels his/her seat before the closure of admissions for the Academic Year 2021-22 an amount of Rs.1,000/- shall be collected as processing fee. The remaining fees already paid during admission shall be refunded.**
16. **If the admitted candidate cancels his/her seat after closure of admissions process for the AY 2021-22 the candidate forfeits the fees already paid (except the caution deposits) and in addition, he/she has to pay an amount of Rs. 1,000/- towards processing fee.**
