- Selection of candidates under BC, SC & ST quota is subject to clearance of the social status by the respective officials from the respective Directorates of Government of Telangana.

- Candidates called for scrutiny and verification of application shall have to attend at their own cost and only one parent / guardian of the candidate will be allowed to accompany the candidate.
- The University doesn't guarantee any employment to the candidates joining the course.
- Candidates are required to read the prospectus thoroughly before attending the verification process and ensure that he / she has fulfilled the eligibility criteria for admission into courses concerned as per ICAR guidelines.
- The candidates selected for admission should submit Medical fitness certificate at the time of reporting in the college.
- In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned
