SPOT counselling for the candidates who have submitted their **ONLINE application** for admission into Bi.P.C. Stream Courses of Professor Jayashankar Telangana State Agricultural University (PJTSAU), Hyderabad and Sri. Konda Laxman Telangana State Horticultural University (SKLTSHU), Mulugu, Siddipet Dist. **under SELF-FINANCING QUOTA** for the Academic Year 2021-22 viz., B.Sc.(Hons.) Agriculture, B.Sc.(Hons.) Community Science & B.Sc.(Hons.) Horticulture based on the Ranks obtained in the Telangana EAMCET–2021 as per the schedule mentioned below:

The candidates seeking admission under Self-financing quota seats may note the following:

- The candidates attending the counselling under Self-financing quota should bring a **Demand Draft** for Rs. 10,12,160 (Ten Lakhs Twelve Thousand One Hundred Sixty Rupees only) drawn in favour of **“THE COMPTROLLER, PJTSAU”** payable at **HYDERABAD** and Rs. 37,840/- (Thirty Seven Thousand Eight Hundred and Forty only) in cash for immediate payment at counseling centre at the respective allotted college counter in the event of selection of the candidate for admission.
- **The candidates who will bring the Demand Draft as indicated above are only eligible to attend to the counselling under self-financing quota.**
- **The Demand Draft should be taken from the Bank Account of the candidate or parent ONLY and in the event of cancellation of the Self-financing seat, the fees shall be refunded through a cheque issued either on the name of student or parent, duly deducting the cancellation fees of Rs. 1,000/-.**

Eligibility:

- A pass in two-year Intermediate Examination conducted by the Board of Intermediate Education, Telangana State or any other examination recognized as equivalent there to by the University or Intermediate Board with the following subjects namely:
 - i) Physical Sciences
 - ii) Biological Sciences

Criteria for selection:

- The selection of the candidates in B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Community Science and B.Sc.(Hons.) Horticulture under Self-financing quota shall be based on the ranks obtained in Telangana State EAMCET-2021 duly following the rule of reservation. The rule of reservation under farmers quota (@ 40%) will also apply for Self-financing quota seats.
- In case of a tie in ranks obtained by two or more candidates in the Telangana State EAMCET-2021, the marks secured in the optional subjects of the qualifying examination (Intermediate) shall be taken into consideration. In case of a further tie, the age of the candidate shall be taken into consideration and the older candidate shall be given preference.

Age:

- The candidates for admission into B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture courses should have completed 17 years of age and the upper age limit shall be 22 years for all the candidates, 25 years in respect of SC and ST candidates and 27 years for Physically Challenged candidates as on 31st December of the year of admission.

Reservation of Seats:

- The rule of reservation (OC:50%, BC-A:7%, BC-B:10%, BC-C:1%, BC-D:7%, BC-E:4%, SC:15% & ST:6%) will be followed as per the rules.
- **The reservation under EWS quota is not applicable under Self-Financing quota.**

Allocation of seats:

- 85% of the seats are reserved for local candidates and 15% of seats are un- reserved.

Hostel facility:

- Hostel facility will be provided subject to availability of accommodation at the respective colleges.
- The fee particulars in respect of B.Sc.(Hons.) Agriculture, B.Sc.(Hons.) Community Science and B.Sc.(Hons.) Horticulture under Self-financing Quota are as follows:

- The hostel and mess charges are additional/extra.

Original certificates and documents to be produced at the time of counselling:

- SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
- Pass Certificate cum Memorandum of Marks obtained by the applicant in the qualifying examination (Intermediate (10+2) or its Equivalent Examination).
- Telangana State EAMCET-2021 Hall Ticket and Rank Card.
- Bonafide / Study Certificate from 6th to 12th Class.
- Transfer Certificate.
- Residential Certificate.
- The latest certified copy of the Social Status Certificate issued by the competent authority in case of applicants belonging to Backward Classes, Scheduled Castes and Scheduled Tribes.
- Non-Municipal Area Study Certificate (ANNEXURE-I).
- Agricultural Land Holding Certificate (ANNEXURE-II).
- The candidates attending the counselling under Self-financing quota should bring a **Demand Draft** for Rs. 10,12,160 (Ten Lakhs Twelve Thousand One Hundred Sixty Rupees only) drawn in favour of **“THE COMPTROLLER, PJTSAU”** payable at **HYDERABAD** and Rs. 37,840/- (Thirty Seven Thousand Eight Hundred and Forty only) in cash for immediate payment at counseling centre at the respective allotted college counter in the event of selection of the candidate for admission.

The candidates seeking admission under Self-financing quota seats may note the following:

- The parents and candidates should visit the University website www.pjtsau.edu.in regularly for updates and the availability of seats under various categories.
- During the sliding process opted by the candidates from one college to another college or one course and another course a few seats may arise in the categories which are not mentioned in the seat availability position.
- All the candidates are informed to visit the website(www.pjtsau.edu.in) for seat availability position before attending the counselling.
- Vacancies if any arise, even on the date of the counselling also will be considered for admission process.
- As this is a Mop Up (Spot counselling), if candidates of one particular social category are not available for admission, such seats will be shifted to another social category as per the rule of reservation. Hence, all the applicants of all categories (OC, BC-A, BC-B, BC-C, BC-D, BC-E, SC & ST - BOTH Non-Rural, Rural, Non-FARMERS & FARMERS) may attend the counselling.
- The candidates who will bring the Demand Draft as indicated above are only eligible to attend to the counselling under self-financing quota.
- The Demand Draft should be taken from the Bank Account of the candidate or parent **ONLY** and in the event of cancellation of the Self-financing seat, the fees shall be refunded through a cheque issued either on the name of student or parent, duly deducting the cancellation fees of **Rs. 1,000/-**.
- The candidates selected under Self-financing quota will be treated on par with regular students. No special amenities or facilities will be provided.
- The candidates admitted under this quota are not eligible for any reimbursement of fee or any other educational concessions offered by the Government.

- **If the admitted candidate cancels his/her seat before the closure of admissions for the Academic Year 2021-22 an amount of Rs.1,000/- shall be collected as processing fee. The remaining fees already paid during admission shall be refunded.**
- **If the admitted candidate cancels his/her seat after closure of admissions process for the AY 2021-22 the candidate forfeits the fees already paid (except the caution deposits) and in addition, he/she has to pay an amount of Rs. 1,000/- towards processing fee.**
- **After closure of admissions process for the AY 2021-22 the candidate forfeits the fees already paid and in addition, he/she has to pay cancellation fees as per the norms of the respective Universities (indicated in the fees structure).**
- **No refund of fee shall be made after closure of admissions process for the AY 2021-22.**
- If the candidates opt sliding and shifting from Self-financing quota to general quota, the differential amount shall be refunded to the account of candidate / parents.
- If the candidate has already joined in any course in either of the three Universities (PJ TSAU, P VNRTVU and SKLTSHU) by paying the requisite fee under regular quota, and if he/she opts for seat under Self-financing quota, the fee already paid under regular quota will be adjusted therein.
- **All the applicants have been called for counseling, hence, admission is not guaranteed and the seats will be allotted based on ranks obtained in Telangana State EAMCET-2021 and rule of reservation.**
- The counseling process is likely to extend late in the evening; hence the candidates and parents/guardians are requested to come well prepared for the same.
- Candidates shall have to attend the counseling at their own cost.
- **The University does not guarantee any employment to the candidates.**
- The applicant is informed that mere submission of online application and attending for counselling does not guarantee a seat.
- **Candidates are required to read the PROSPECTUS thoroughly before attending the counselling.**
- In case, the information furnished or the certificates uploaded by the candidates are found to be false, the University will take appropriate action against the individuals concerned.
- The parents and candidates should regularly visit the University website www.pjtsau.edu.in for any further information.
- Professor Jayashankar Telangana State Agricultural University (PJ TSAU) is the only Agricultural University in the State. The University has not accorded any affiliation to any private colleges in Telangana State.
- The University is not responsible for the information provided in other websites.
- Parents and Students are informed that the admissions are purely based on merit and guidelines of the University and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into PJ TSAU under any quota. All the seats will be filled by the University only.
