Professor Jayashankar (PJTSAU) Life Time Achievement Award

Regulations governing the award

Preamble

The award is named after the Telangana ideologue Prof. K. Jayashankar, Former Vice chancellor of Kakatiya University and an eminent economist. The Telangana State Agricultural University was named in his memory, considering that he advocated equitable water resource sharing which is very essential for agriculture, the lifeline for Telangana's economy. The Award will be conferred biennially on an eminent Indian scientist(scientists) who worked in India in any branch of Agricultural Sciences (Crop/Animal/Fisheries/Agricultural Engineering) for enhancing productivity. This award is instituted by Professor Jayashankar Telangana State Agricultural University, Hyderabad, India.

The Award

This is a biennial Award for the **remarkable achievements** to the cause of Indian agriculture by the scientist. The award carries a Cash prize of Rs.1.0 Lakh (Rupees One Lakh only), a Medal and a Citation.

Eligibility

Any citizen of India residing in India who is engaged in research in any field of Agriculture (Crop / Animal /Fisheries/Agricultural Engineering) Sciences is eligible for the award. All the NRI's who are staying in different countries and involved in any field of Agriculture (Crop/Animal/Fisheries/Agricultural Engineering) and its related Sciences who made outstanding contributions to Indian Agriculture, with particular relevance and impact on Indian Agriculture are also eligible for the award. The applicant/ nominee should have a standing of 15 years in the concerned field and below 65 years age at the time of applying for the award.

Selection procedure

Selection of the Awardee shall be made by a committee of experts, constituted by the Vice Chancellor. The experts shall be renowned scientists and eminent personalities in the relevant fields of Agriculture (Crop/Animal/Fisheries/Agricultural Engineering)not below the cadre of DDG's& Vice Chancellor.

Award Function

The award will be presented on the 3rd September, 2023, the Foundation Day of PJTSAU, at Hyderabad. The awardee shall be intimated through official communication by the University and on receiving confirmation, he/she shall be invited to make an acceptance speech and deliver a presentation on the subject in which he/she has made notable contributions.

Nominations

Name(s) of candidate(s) may be sponsored by the Presidents of academies of all-India character; Vice Chancellors of Indian/Foreign Universities, deemed Universities and Institutions of national importance; Directors General of ICAR and CSIR, Directors of ICAR and CSIR, Institutes and Managing Directors of Public and Private organisations and NGOs related to any field of Agriculture (Crop/Animal/Fisheries) and Secretaries/ Heads of the Government Science and Technology Departments. Scientists who have superannuated from service may send their nominations directly. However, the application (Proforma I & II) of the Retired Scientist who applies for the award should be certified by the Head of the Institute where he/she worked and retired. In the certificate the official seal should be affixed. The nomination in the prescribed proforma should be accompanied by a statement of work attainments of the nominee, limited to six typed pages (5 copies duly signed) and an epitomised account of the work in the proforma enclosed (5 copies duly signed).

The nominations duly filled in and superscribed on the cover as "NOMINATION FOR PROFESSOR JAYASHANKAR (PJTSAU) LIFE TIME ACHIEVEMENT AWARD" should be sent to Registrar, Admn. office PJTSAU, Rajendranagar, Hyderabad -500 030 Telangana, India.

The last date for receipt of nominations is 15-08-2023.
