#### 1. Name of the Award

Progressive Farmer Award

## 2. Sponsorship of the award

## 3. Objective

To recognize outstanding contribution progressive farmers in the field of agriculture.

# 4. Number of Awards and Frequency

The award consists of a plaque and a citation.

## 5. Administration of the award

A five member Judging Committee consisting of Director of Extension as Chairman, three experts from outside the University and having experience in judging the ability of farmers and one member from state Department of Agriculture note below the rank of Joint Director of Agriculture or a persion nominated by the Director of Agriculture and make suitable recommendations to the University. In case no suitable application is received the award shall not be given that year. The decision of University shall be final in this regard.

## 6. Eligibility Criteria

Any farmer self involved in diversified rural activities / enterprises such as Agriculture and related activities like in Horticulture, Animal Husbandry, Fisheries, Rural Artisans / Handicraft activities for the last 10 years.

#### 7. Area of Award

The award will be for the creative approach – innovative farming, technological acceptance, contribution to enhanced productivity, farming attributes shown by a farmer. This may involve activities like farmers innovations in resource conservation and enhancement, germplasm collection and conservation of plant, management practices, soil and water management / conservation, development of appropriate tools and equipment, innovations in dry farming techniques / practices, new improved food and feed products and control of diseases among crops processing of agricultural produce and marketing.

#### 8. Criteria of Selection

The farmer's innovations / creativity / approaches should result:

- i. New knowledge / package of practices / management strategies / additional information to the existing one resulting in productivity enhancement from land, processing, value addition, marketing etc.
- ii. Additional income to the individual farmer / farming community
- iii. Saving of resource / inputs
- iv. Breaking technology transfer barriers
- v. Extent of motivation to other farmers
- vi. Preference shall be given to small and marginal farmers

## 9. Procedure for Nomination:

The KVKs/DAATT centres shall identify the farmers and request them to apply in the prescribed application (downloaded from the University website), and submit the applications in the prescribed format along with recommendations of Head KVK/DAATTC and countersigned by the ADR of respective zone. The application shall be sent to the Director of Extension, Admn. Office, PJTSAU, Rajendranagar, Hyderabad.

10. **Presentation of the Award:** Award in the form of a citation and a plaque to be presented on the foundation day of the University i.e., 3<sup>rd</sup> September.
