TERMS AND CONDITIONS FOR DISPOSALOF OLD VEHICLES AT TRANSPORT WORK SHOP (AGRICULTURAL RESEARCH INSTITUTE PJTSAU, RAJENDRANAGAR, HYDERABAD – 500 030.)

- The Tender form along with offer and EMD should be submitted in a sealed envelope superscripted with the words "TENDER FOR THE PURCHSE OF OLD VEHICLE NO...... Separate tender form and EMD shall be submitted for each vehicle. Tenders should be submitted to the Transport Officer, Professor Jayashankar Telangana State Agricultural University, Rajendranagar, Hyderabad -500 030 by Registered post acknowledgement due or in person so as to reach before 5.00 PM on 27.09.2024. Tender offers received after the due date and time are liable to be rejected summarily. If tenders are presented in open cover or envelop it shall not be the responsibility of the Officer concerned to maintain secrecy of the amount of tender etc. and they shall be rejected outright.
- 2. The offer shall not be less than the upset value. Any amount quoted less than the upset value shall be rejected summarily and the same shall be put in open auction on the same day.
- 3. Amounts once entered should not be altered and they should also be written in words in the place provided.
- 4. The Tender form shall accompany DD favoring the Comptroller, PJTSAU, Rajendranagar towards Earnest Money Deposit (EMD) as follows:
 - a) Light Motor Vehicle Rs.10,000-00 (Rupees Ten thousand only)
 - b) Heavy Vehicle Rs.25,000-00 (Rupees Twenty five thousand only)
- 5. The Tenders will be opened in the presence of Tenders or their agents who will be read out to them. Right of acceptance of otherwise is reserved with the University Auction Committee without assigning any reasons whose decision is final and binding on all parties.
- 6. If the offer quoted is same by two or more tenderers, open auction will be conducted on the same day.
- 7. All vehicles in this tender are proposed to be disposed in "as is where is" condition.
 - a) The University has no responsibility to clear the tax and Insurance dues etc. and will not pay or reimburse any amount that may be incurred by the successful bidder in getting the vehicle ownership transferred on his name.
 - b) The successful bidder has to obtain the No objection Certificate from the respective R.T.A and transfer the ownership at his own expenses.
 - c) The name of the successful bidder will be announced on the day of opening tenders on 30.09.2024 and postal intimation will be sent. The University is not responsible for postal delay.
- 8. University reserves right to acceptance or reject the tender.
- 9. Delivery of vehicle to proxy will be at the successful bidder whole responsibility and risk, and no claim shall be against the University on any amount what so ever, if delivery is affected to a wrong person.
- 10. The successful bidder shall be responsible for any damage that may be occur to the premises in taking delivery or removing the vehicles bought by him.

- 11. If the successful bidder fails to pay the full amount within the time prescribed or if the tenderer fails to accept the bid, he shall be forfeited the EMD and shall have no right to claim the same.
- 12. In the event of any dispute arising in connection with the disposal of vehicles the decision of the University Auction Committee shall be final and binding on all parties.
- 13. If the successful bidders do not remove the vehicles from the University premises within stipulated period.
 - a) An amount of Rs.200/- per day up to 5 days and
 - b) Rs.1000/- per day after 5 days will be charges as storage charges.
- 14. The EMD amount to the unsuccessful bidders will be returned to the authorized person or returned by Registered post to the tenderers address within one month to the address mentioned in the tender form. The University does not hold any responsibility in postal delay or non-delivery of the registered letter by postal department.
